




NON-GREASING GAUGE WHEEL AXLES

INSTALL GUIDE

***These can be clamped on tightly and difficult to remove. Try removing the cover plate and allowing the depth arm

cover plate and allowing the depth arm to hang down, you can now access the shank from an uninhibited angle and tap off gently with a hammer.



Remove old Axle

***If seized, cut end of arm off to reveal spindle nut




Remove old seal



Remove spindle nut

***Left hand openers have left hand thread spindle nuts



Remove spindle, remember to suport the hub whilst doing this



Install the new axle shaft and spindle nut together



Install spindle nut
***Left hand openers have left hand
thread spindle nuts



Torque spindle nut to 120ft/lbs
***Do not overtighten this spindle nut as
this can inhibit axle rotation




Install new seal
***Do NOT hammer seal hard against the
nut face. Check seal is tight on collar, and
flat face is to the hub



Apply a smear of copper coat or grease to the arm cap
***NOT the spline connection



Apply a smear of copper coat or grease to the seal



Locate the arm into the spline

***When installed your axle shaft head
and arm will face opposite directions
as shown



Install the flange nut



Torque the flange nut to 120ft/lbs
***We do not recommend removing this
nut and arm to assist in disc removal



Reattach the depth adjustment arm securely

***The clamping jaws of the old depth arms may need grinding to accommodate the new axle head. (The gap decreases overtime due to worn axle heads and tight clamping)

Internal spacer
***Pro-series units, the internal
spacer forms part of the arm

Outer spacer and seal
***Apply smear of grease to the hub
seals
