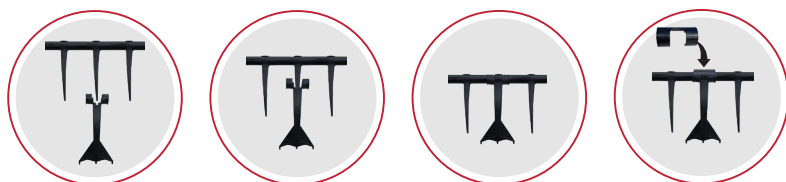

STATEMENT OF LIMITED WARRANTY

FOR DUCK FOOT® PRODUCTS

Duck Foot Parts, Inc. ("Duck Foot") warrants its products to be free from defects in materials and workmanship for a period of one (1) year from the date of the original purchase of the products by the original purchaser from Duck Foot or from Duck Foot's authorized representatives, dealers or resellers.

Duck Foot agrees, at its option during the warranty period, to replace the product for which a warranty claim is made without charge. Such replacement is subject to verification of the defect and proof of purchase as confirmed by showing the original dated sales receipt.

LIMITATIONS TO WARRANTY

This warranty is non-transferrable, and any sale, transfer, or disposal of the product will void this warranty as this warranty only extends to the original purchaser of Duck Foot products that are purchased directly from Duck Foot or from Duck Foot's authorized representatives, dealers or resellers.

This warranty does not cover any of the following: (a) warranty claims resulting from improper installation of the product; or (b) any product damaged by accident, abuse, misuse, negligence, improper operation or maintenance; (c) any unauthorized alteration or modification of the product; (d) normal wear and tear; or (e) pre-owned, refurbished, demo or sample, or "as-is" products or products not purchased directly from Duck Foot or an authorized representative, dealer or reseller of Duck Foot products.

WARRANTY PROCEDURE

Claims for defective products must be made within one year from the date of the original purchase reflected on the original dated sales receipt. The defective product must be returned, at the original purchaser's expense, to Duck Foot or to the Duck Foot representative, dealer or reseller from whom the product. If, after inspection of the returned product, Duck Foot considers the claim to be justified, the product or part will be replaced without charge.

LIMITATION OF LIABILITY

Any description of the products, including any reference to the product's specifications, or descriptions of the products in circulars, or any other written material published by Duck Foot is for the sole purpose of identifying such products and shall not create an express warranty that the products will conform to such description. No representative of Duck Foot nor any dealer or reseller associated with Duck Foot has the authority to change the terms and conditions of this warranty in any manner whatsoever.

This warranty is in lieu of all other warranties, express or implied. There are no implied warranties of merchantability or fitness for a particular purpose.

This warranty states Duck Foot's entire and exclusive liability and the original purchaser's exclusive remedy for any claim for damages in connection with the sale of Duck Foot products, their design, suitability for use, installation or operation, or for any claimed defects herein.

In no event will duck foot be liable for any special, incidental, indirect or consequential damages whatsoever arising from the sale or use of any duck foot product, part or component. The total liability of duck foot for any reason, including but not limited to, mistake, negligence, act, omission and breach, shall not exceed in the aggregate the purchase price paid by the original purchaser for such product. This disclaimer and exclusion applies even if the product fails for its essential purpose.
