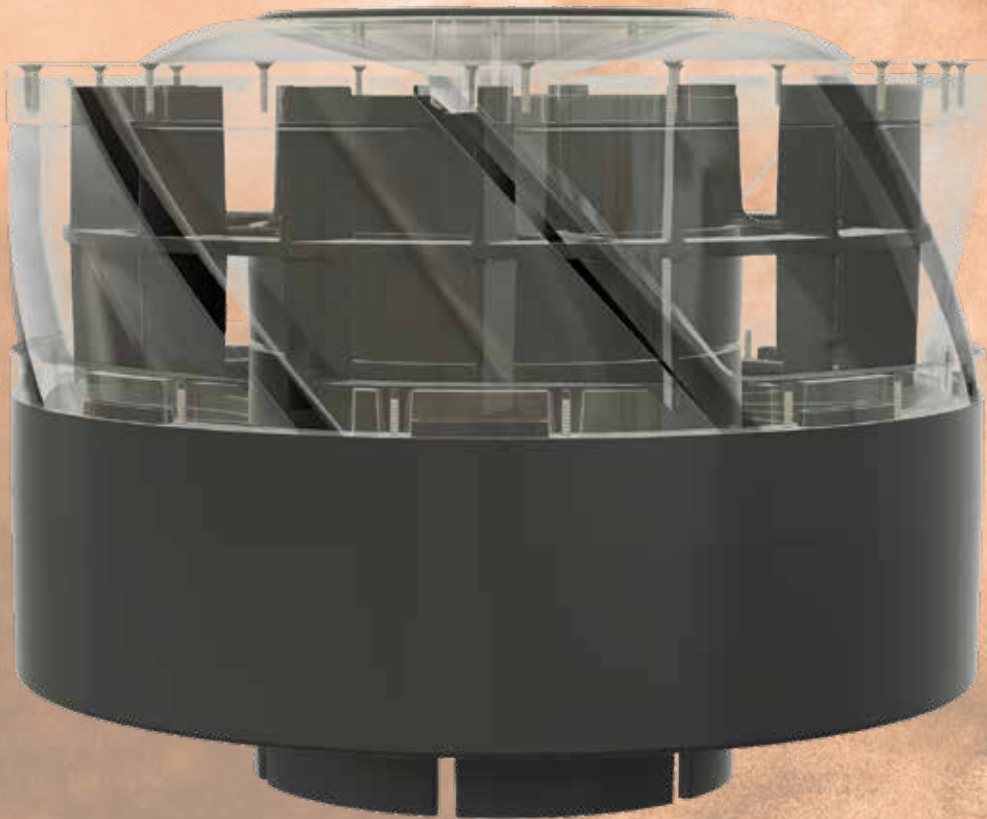

## Safety Instructions

**IMPORTANT:** Read through this manual thoroughly and familiarize yourself with the KAS Pre-cleaner before installation of these components.

This manual explains the proper procedure for installation of the KAS Pre-cleaner. Do not skip steps or perform them out of order.



## Recognize Safety Information

This is a safety-alert symbol. When you see this symbol on your straw chopper or in this manual, be alert to the potential for personal injury.

Follow recommended precautions and safe operating practices.



## Understand Signal Words

A signal word - DANGER, WARNING, or CAUTION - is used with the safety-alert symbol. DANGER identifies the most serious hazards.

WARNING or CAUTION safety signs are located near specific hazards or precautionary areas in this manual.



## Work In Ventilated Area

Engine exhaust fumes can cause sickness or death. If it is necessary to run an engine in an enclosed area, remove the exhaust fumes from the area with an exhaust pipe extension.

If you do not have an exhaust pipe extension, open the doors and get outside air into the area.

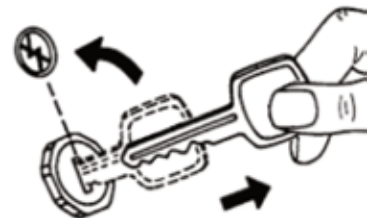


## Remove Key from Ignition

**ALWAYS** shut off machine engine prior to working on it.

Apply park brake, remove key and lock operators cab.

If the machine is equipped with an additional safety master power switch, turn this to the Power OFF position.



### Block Wheels

Park the machine on level ground.

Always engage the park brake and block the wheels prior to working to prevent the machine from moving.



### Practice Safe Maintenance

Understand service procedure before doing work. Keep area clean and dry.

Never lubricate, service, or adjust machine while it is moving. Keep hands, feet and clothing away from power-driven parts. Disengage all power and operate controls to relieve pressure. Lower equipment to the ground. Stop the engine. Remove the key. Allow machine to cool.

Securely support any machine elements that must be raised for service work.

Keep all parts in good condition and properly installed. Fix damage immediately. Replace worn or broken parts. Remove any buildup of grease, oil or debris.



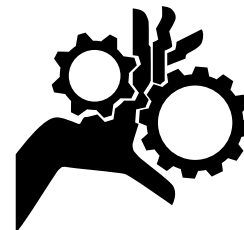
### Guards and Shields

Keep guards and shields in place at all times. Ensure that they are serviceable and maintained correctly.



### Avoid Contact With Moving Parts

Keep hands, feet and clothing away from power driven parts. Never clean, lubricate or adjust machine when it is running.



### Dispose of Waste Properly

Improperly disposing of waste can threaten the environment and ecology. Potentially harmful waste includes such items as oil, fuel, coolant, brake fluid, filters and batteries.

Use leakproof containers when draining fluids. Do not use food or beverage containers that may mislead someone into drinking from them.

Do not pour waste onto the ground, down a drain or into any water source.

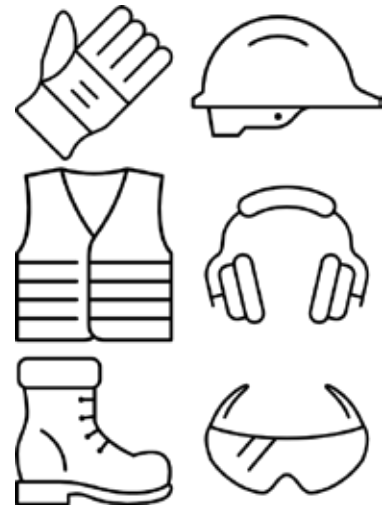


### Personal Protective Equipment (PPE)

A qualified person designated by the employer, who is knowledgeable about and familiar with all relevant specifications and assembly instructions and is capable of identifying existing or potential hazards in surroundings or working conditions which may be hazardous or dangerous to employees shall determine appropriate Personal Protective Equipment required for this assembly.

Personal Protective Equipment (PPE) are devices worn by the employees to protect against hazards in the environment. Examples include safety glasses, face shields, respirators, gloves, hard hats, steel-toe shoes, and hearing protection. Wear close fitting clothing and safety equipment appropriate for the job.

Operating equipment safely requires the full attention of the operator. Do not wear music headphones while operating machine.



### Prepare for Emergencies

Be prepared if a fire starts.

Keep a first aid kit and fire extinguisher handy.

Keep emergency numbers for doctors, ambulance service, hospital and fire department near your telephone.



## In the Event of Fire

Stop work immediately at first sign of fire. This may be the smell of smoke or the sight of smoke or flames. Get off the machine immediately and move away from the fire. Do not return to the machine or fire!



**CAUTION: Avoid personal injury.**

If a fire is too far advanced, do not try to extinguish it. Call the fire department! The number one priority is safety. Always put the safety of the operator and bystanders first. If a fire can be safely extinguished, proceed carefully and follow these guidelines:

1. Remove fire extinguisher from bracket and carry it to the area of fire.
2. Approach area of fire with your back to the wind.
3. Pull the safety pin out of actuating lever.
4. Hold extinguisher upright, pointing nozzle away from you and aim hose at base of the flames.
5. Squeeze the lever slowly and evenly to discharge fire extinguisher.
6. Move extinguisher nozzle side to side to cover the source of the fire evenly with extinguishing agent.



## Safety Decals

### Pictorial Safety Signs

At several important places on this machine, safety signs are affixed intending to signify potential danger. The hazard is identified by a pictorial in a warning triangle. An adjacent pictorial provides information on how to avoid personal injury. These safety signs and a brief explanatory text follow.

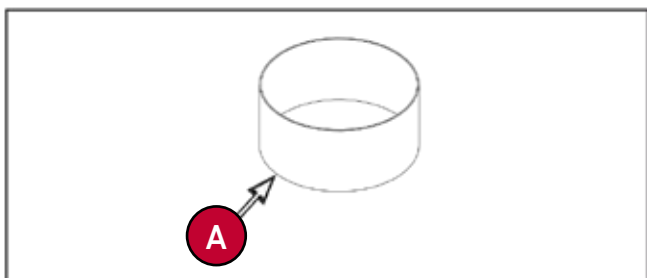

This operator's manual contains all important information necessary for safe machine operation. Carefully observe all safety rules to avoid accidents.





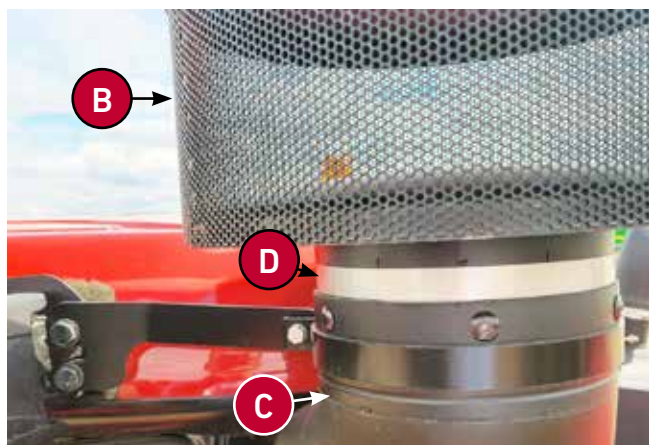

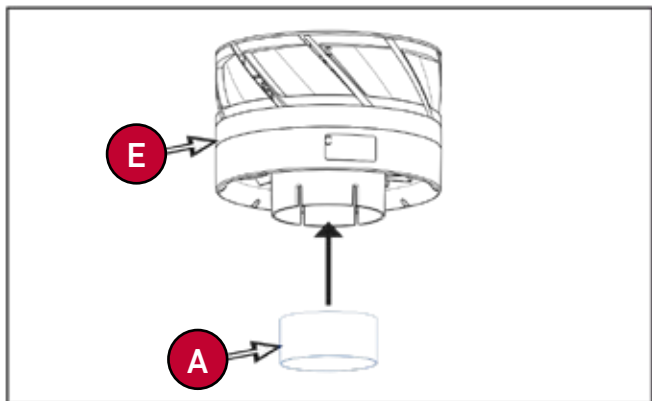

**1. Remove top air intake screen (B) from air intake tube (C)**



**2. Loosen hoseclamp (D) holding air intake screen (B) on air intake tube (C)**

3. Insert pipe extension (A) into KAS Air Cleaner (E) until it bottoms out on inside edge

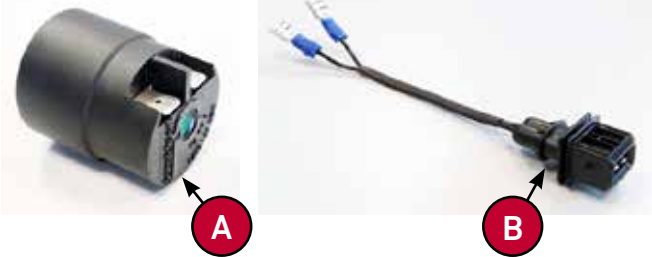


4. Install KAS Pre-Cleaner (E) with pipe extension inserted onto air intake tube (C), secure in place with hose clamp (F) as per instructions with the Pre-Cleaner



5. View with KAS Pre-Cleaner (E) installed

### VACUUM SWITCH REPLACEMENT



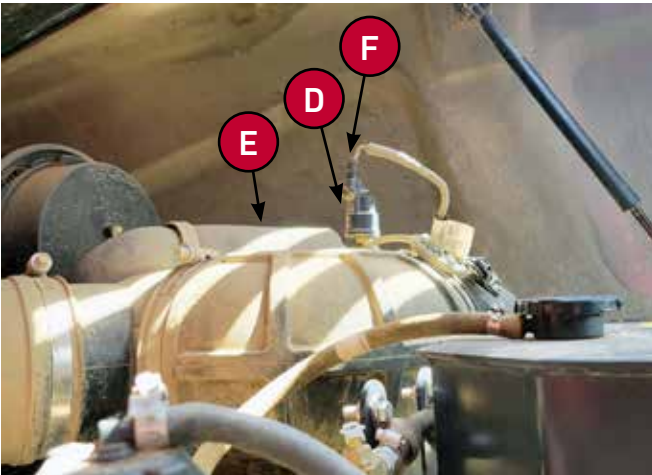

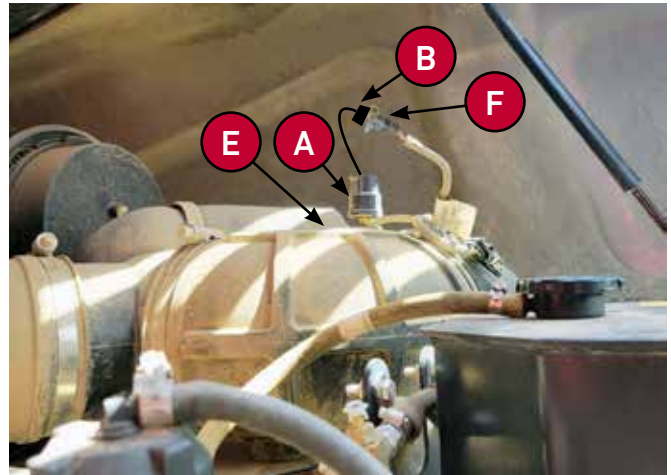


1. Open hood (C) of the tractor



2. Locate and remove OEM engine air filter vacuum switch (D) from on top of the engine air intake piping (E) located on top of the engine

3. Remove by unplugging the wiring harness (F) and unscrewing the vacuum switch (D)  
- Not to be reused



4. Install new vacuum switch (A) in place of the old one

5. Install by screwing the vacuum switch into the intake piping (E)

6. Plug adaptor harness (B) into vacuum switch (A) and wiring harness (F)




**CAUTION**

The KAS Pre-cleaner may be the tallest point on the machine
